CERTIFICATION BLOCKS Attachment to Development Application – January 02, 2020

The following certification blocks have been adopted by reference (10-7-2(C)2) and shall be included on the cover sheet of all new plans, as applicable.

Owner Certificates

Owner certificates must be signed by the property owner as shown on a current title commitment for the subject property. If a designated agent signs, he/she must supply the city with a notarized power of attorney which shows his/her authority to sign the plan and which shall be recorded with the plan. Plans submitted for approval by corporations must be signed by either the president or vice president of the corporation and attested to by the corporate secretary or assistant secretary. The corporate seal shall also be shown on the plan. Where a plan is submitted by a limited partnership, only a general partner may sign the plan. Any partner in a partnership may sign the plat. A member of a Colorado limited liability company may sign the plan. If the owner is a limited liability company formed in another state, copies of the operating documents for the company must be submitted so that the city attorney may determine the appropriate plan signatory.
