8 COLORADO, AMENDING ORDINANCE 23, SERIES 2022
9 KNOWN AS THE “ANNUAL APPROPRIATION BILL”

16 WHEREAS, Ordinance No. 23, Series 2022 established the annual appropriation
17 for municipal purposes for the City of Littleton, Colorado; and

18
19 WHEREAS, appropriations have theretofore been made for the expenditures of
20 monies pursuant to said budget; and

22 WHEREAS, the necessity of receiving and expending additional monies from the
23 general funds could not have been reasonably anticipated during the time of the adoption of the
24 budget and appropriation of funds in accordance therewith.

26 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
27 THE CITY OF LITTLETON, COLORADO, THAT:

29 Section 1: The budget of the City of Littleton for the fiscal year beginning January
30 1, 2023, and ending December 31, 2023, is hereby amended by the following additions:

36 Section 2: The provisions of the annual appropriations Ordinance No. 23, Series
37 of 2022, are hereby amended with the total of all fund expenditures amended to \$114,249,806.

40 Section 3: Severability. If any part, section, subsection, sentence, clause or
41 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
42 validity of the remaining sections of this ordinance. The City Council hereby declares that it would
43 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase
44 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or
45 phrases may be declared invalid.

47 Section 4: Repealer. All ordinances or resolutions, or parts thereof, in conflict

48 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer
49 clauses of such ordinance nor revive any ordinance thereby.

52 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council
53 of the City of Littleton on the 6th day of December, 2022, passed on first reading by a vote of 6
54 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the
55 Municipal Courthouse and on the City of Littleton Website.

56 PUBLIC HEARING on the Ordinance to take place on the 20th day of December,
57 2022, in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado, at
58 the hour of 6:30 p.m., or as soon thereafter as it may be heard.
