**AN ORDINANCE OF THE CITY OF LITTLETON, COLORADO, AMENDING ORDINANCE 23, SERIES 2022 KNOWN AS THE “ANNUAL APPROPRIATION BILL” ADOPTING THE BUDGET FOR ALL MUNICIPAL PURPOSES OF THE CITY OF LITTLETON, COUNTIES OF ARAPAHOE, DOUGLAS, AND JEFFERSON, STATE OF COLORADO, FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2023 AND ENDING DECEMBER 31, 2023**

**WHEREAS**, Ordinance No. 23, Series of 2022 established the annual appropriation for municipal purposes for the City of Littleton, Colorado; and

**WHEREAS**, Ordinance No. 33, Series of 2022 amended the annual appropriation for municipal purposes for the City of Littleton, Colorado; and

**WHEREAS**, Ordinance No. 01, Series of 2023 amended the annual appropriation for municipal purposes for the City of Littleton, Colorado; and

**WHEREAS**, Ordinance No. 04, Series of 2023 amended the annual appropriation for municipal purposes for the City of Littleton, Colorado; and

**WHEREAS**, appropriations have theretofore been made for the expenditures of monies pursuant to said budget; and

**WHEREAS**, the necessity of receiving and expending additional monies from the general funds could not have been reasonably anticipated during the time of the adoption of the budget and appropriation of funds in accordance therewith.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:**

**Section 1:** The budget of the City of Littleton for the fiscal year beginning January 1, 2023, and ending December 31, 2023, is hereby amended by the following additions:

Grant Fund	\$1,500,000
Capital Projects Fund	\$ 404,990

**Section 2:** The provisions of the annual appropriations Ordinance No. 23, Series of 2022, are hereby amended with the total of all fund expenditures amended to \$142,746,334.

49 **Section 3:** Severability. If any part, section, subsection, sentence, clause or  
50 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the  
51 validity of the remaining sections of this ordinance. The City Council hereby declares that it would  
52 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase  
53 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or  
54 phrases may be declared invalid.

56 **Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in conflict  
57 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer  
58 clauses of such ordinance nor revive any ordinance thereby.

62 of the City of Littleton on the 6<sup>th</sup> day of June, 2023, passed on first reading by a vote of 7 FOR

64 Municipal Courthouse and on the City of Littleton Website.
