16 **WHEREAS,** Ordinance No. 23, Series of 2022 established the annual
17 appropriation for municipal purposes for the City of Littleton, Colorado; and

19 **WHEREAS,** Ordinance No. 33, Series of 2022, Ordinance No. 01, Series of 2023,
20 Ordinance No. 04, Series of 2023, Ordinance No. 10, Series of 2023 amended the annual
21 appropriation for municipal purposes for the City of Littleton, Colorado; and

23 **WHEREAS,** appropriations have theretofore been made for the expenditures of
24 monies pursuant to said budget; and

25
26 **WHEREAS,** the necessity of receiving and expending additional monies from the
27 general funds could not have been reasonably anticipated during the time of the adoption of the budget
28 and appropriation of funds in accordance therewith.

30 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF**
31 **THE CITY OF LITTLETON, COLORADO, THAT:**

33 **Section 1:** The budget of the City of Littleton for the fiscal year beginning January
34 1, 2023, and ending December 31, 2023, is hereby amended by the following additions:

41 **Section 2:** The provisions of the annual appropriations Ordinance No. 23, Series
42 of 2022, are hereby amended with the total of all fund expenditures amended to \$146,375,535.

44 **Section 3:** Severability. If any part, section, subsection, sentence, clause or
45 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
46 validity of the remaining sections of this ordinance. The City Council hereby declares that it would
47 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase

48 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or
49 phrases may be declared invalid.

51 **Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in conflict
52 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer
53 clauses of such ordinance nor revive any ordinance thereby.

56 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council

57 of the City of Littleton on the 1st day of August, 2023, passed on first reading by a vote of 7 FOR

58 and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the

59 Municipal Courthouse and on the City of Littleton Website.

60 PUBLIC HEARING on the Ordinance to take place on the 15th day of August,

61 2023, in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado, at

62 the hour of 6:30 p.m., or as soon thereafter as it may be heard.

64 PASSED on second and final reading, following public hearing, by a vote of 5 FOR and

65 0 AGAINST on the 15th day of August, 2023 and ordered published by posting at Littleton Center,

66 Bemis Library, the Municipal Courthouse and on the City of Littleton Website.
