AN ORDINANCE OF THE CITY OF LITTLETON, COLORADO, AS THE GOVERNING BODY OF THE CITY OF LITTLETON, COLORADO, SEWER UTILITY ENTERPRISE, AMENDING THE 2023 LITTLETON SEWER UTILITY ENTERPRISE BUDGET

WHEREAS, the city council established the City of Littleton, Colorado, Sewer Utility Enterprise (the “Enterprise”) by Ordinance No. 6, Series of 2004; and

WHEREAS, the city council, as the governing body of the Enterprise, has the authority under said ordinance to establish the budget for the Enterprise; and

WHEREAS, Ordinance No. 24, Series of 2022 established the budgeted expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise; and

WHEREAS, Ordinance No. 06, Series of 2023 amended the established the budgeted expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:

Section 1: The budgeted expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise for the period January 1, 2023 to December 31, 2023 are hereby amended by the following addition:

<u>FUND</u>	<u>EXPENDITURE</u>
Sewer Utility Enterprise	\$ 1,100,000

Section 2: The total budgeted expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise for the period January 1, 2023 to December 31, 2023 shall be amended to \$29,143,094.

Section 3: Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or phrases may be declared invalid.

Section 4: Repealer. All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer
