7 AN ORDINANCE OF THE CITY OF LITTLETON,  
8 COLORADO, AS GOVERNING BODY OF THE CITY OF  
9 LITTLETON, COLORADO, SEWER UTILITY  
10 ENTERPRISE, AMENDING THE 2024 SEWER UTILITY  
11 UTILITY ENTERPRISE BUDGET

13 WHEREAS, the city council established the City of Littleton, Colorado Sewer  
14 Utility Enterprise (the “Enterprise”) by Ordinance No. 6, Series of 2004; and

15  
16 WHEREAS, the city council, as the governing body of the Enterprise, has the  
17 authority under said ordinance to establish the budget for the Enterprise; and

18  
19 WHEREAS, Ordinance No. 26, Series of 2023 established the budgeted  
20 expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise; and

21  
22 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF  
23 THE CITY OF LITTLETON, COLORADO, THAT:

25 Section 1: The budgeted expenditures for the City of Littleton, Colorado, Sewer  
26 Utility Enterprise for the period of January 1, 2024 to December 31, 2024, are hereby amended by  
27 the following addition:

FUND	EXPENDITURES
Sewer Utility Enterprise	\$132,905

31 Section 2: The total budgeted expenditures for the City of Littleton, Colorado,  
32 Sewer Utility Enterprise for the period of January 1, 2024 to December 31, 2024 shall be amended  
33 to \$27,669,032.

35 Section 3: Severability. If any part, section, subsection, sentence, clause or  
36 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the  
37 validity of the remaining sections of this ordinance. The City Council hereby declares that it would  
38 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase  
39 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or  
40 phrases may be declared invalid.

41  
42 Section 4: Repealer. All ordinances or resolutions, or parts thereof, in conflict  
43 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer  
44 clauses of such ordinance nor revive any ordinance thereby.

47 INTRODUCTION AS A BILL at a regularly scheduled meeting of the City Council  
48 of the City of Littleton on the 5<sup>th</sup> day of March, 2024, passed on first reading by a vote of 6  
49 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library,  
50 the Municipal Courthouse and on the City of Littleton Website.

51 PUBLIC HEARING on the Ordinance to take place on the 19<sup>th</sup> day of March, 2024,  
52 in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado, at the  
53 hour of 6:30 p.m., or as soon thereafter as it may be heard.
