18 WHEREAS, Ordinance No. 39, Series of 2018 established the annual
19 appropriation for municipal purposes for the City of Littleton, Colorado; and

21 WHEREAS, Ordinance No. 2, Series of 2019 amended the annual appropriation
22 for municipal purposes for the City of Littleton, Colorado; and

24 WHEREAS, Ordinance No. 6, Series of 2019 amended the annual appropriation
25 for municipal purposes for the City of Littleton, Colorado; and

27 WHEREAS, Ordinance No. 18, Series of 2019 amended the annual appropriation
28 for municipal purposes for the City of Littleton, Colorado; and

30 WHEREAS, appropriations have theretofore been made for the expenditures of
31 monies pursuant to said budget; and

33 WHEREAS, the necessity of receiving and expending additional monies from the
34 various funds could not have been reasonably anticipated during the time of adoption of the budget
35 and appropriation of funds in accordance therewith.

37 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
38 THE CITY OF LITTLETON, COLORADO, THAT:

40 Section 1: The budget of the City of Littleton for the fiscal year beginning
41 January 1, 2019, and ending December 31, 2019, is hereby amended by additions to the following
42 funds:

FUND	EXPENDITURES
General Fund	\$180,000
Geneva Village Fund	\$26,000
Employee Insurance Fund	\$250,000
Property and Liability Fund	\$50,000
Total	\$506,000

2 **Section 2:** The provisions of the annual appropriations Ordinance No. 39, Series
3 of 2018, are hereby amended with the total of all fund expenditures amended to \$79,840,791.

5 **Section 3:** Severability. If any part, section, subsection, sentence, clause or
6 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
7 validity of the remaining sections of this ordinance. The City Council hereby declares that it would
8 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase
9 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or
10 phrases may be declared invalid.

12 **Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in conflict
13 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer
14 clauses of such ordinance nor revive any ordinance thereby.

17 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council
18 of the City of Littleton on the 3rd day of December, 2019, passed on first reading by a vote of 7
19 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the
20 Municipal Courthouse and on the City of Littleton Website.

21 PUBLIC HEARING on the Ordinance to take place on the 17th day of December,
22 2019, in the Council Chambers, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado,
23 at the hour of 6:30 p.m., or as soon thereafter as it may be heard.

24 PASSED on second and final reading, following public hearing, by a vote of ____
25 FOR and ____ AGAINST on the 17th day of December, 2019, and ordered published by posting at
26 Littleton Center, Bemis Library, the Municipal Courthouse and on the City of Littleton Website.
