**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, REFERRING TO THE REGISTERED ELECTORS OF THE CITY OF LITTLETON, COLORADO, A QUESTION AUTHORIZING THE CITY TO RETAIN AND SPEND ALL TAXES, GRANTS AND OTHER REVENUES RECEIVED IN 2016 IN EXCESS OF ITS REVENUE/EXPENDITURE LIMITATION AS PROVIDED IN ARTICLE X, SECTION 20, OF THE COLORADO CONSTITUTION, COMMONLY KNOWN AS AMENDMENT ONE OR THE TABOR AMENDMENT.**

**WHEREAS**, in 2016 and thereafter City revenues, including taxes, grants and other revenues, may exceed the revenue limitations set by Article X, Section 20 of the Colorado Constitution: and ;

**WHEREAS**, pursuant to said constitutional provision, the City is authorized to retain and expend such monies in excess of said limitation, only when authorized by a vote of the registered electors of the City.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:**

**Section 1:** The City Clerk is hereby authorized to submit to the registered voters of the City of Littleton, Colorado at the Biennial City election to be held on November 7, 2017, the following ballot title and question:

**WITHOUT CREATING ANY NEW TAX OR INCREASING ANY CURRENT TAXES, SHALL THE CITY OF LITTLETON, COLORADO BE AUTHORIZED TO RETAIN AND SPEND ALL TAXES, GRANTS AND OTHER REVENUES RECEIVED IN 2016 IN EXCESS OF LIMITATIONS ESTABLISHED BY ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION, USING SUCH EXCESS EXISTING REVENUES ONLY FOR CAPITAL PROJECTS TO INCLUDE SOME OR ALL OF THE FOLLOWING USES AND ALLOCATIONS DEPENDING ON THE AVAILABILITY OF FUNDS, WITH ALL PROVISIONS OF ARTICLE X, SECTION 20, OF THE COLORADO CONSTITUTION REMAINING IN EFFECT, INCLUDING VOTER APPROVAL OF ANY NEW TAX, TAX RATE INCREASE OR ADDITIONAL DEBT?**
