8 AN ORDINANCE OF THE CITY OF LITTLETON,  
9 COLORADO, AMENDING THE 2022 LITTLETON SEWER  
10 UTILITY ENTERPRISE BUDGET

12 WHEREAS, the city council established the City of Littleton, Colorado, Sewer  
13 Utility Enterprise (the “Enterprise”) by Ordinance No. 6, Series of 2004; and

14  
15 WHEREAS, the city council, as the governing board of the Enterprise, has the  
16 authority under said ordinance to establish the budget for the Enterprise; and

17  
18 WHEREAS, Ordinance No. 28, Series of 2021 established the budgeted  
19 expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise; and

20  
21 WHEREAS, the city council has determined it is in the best interest of all  
22 ratepayers to separate the cost of treatment versus the cost to operate, maintain and improve  
23 through capital construction the systems necessary to collect and transport the discharge for  
24 treatment; and

25  
26 WHEREAS, the necessity of receiving and expending additional monies from the  
27 Enterprise could not have been reasonably anticipated during the time of adoption of this budget  
28 and appropriation of funds in accordance therewith.

30 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF  
31 THE CITY OF LITTLETON, COLORADO, THAT:

32  
33 Section 1: The budgeted expenditures for the City of Littleton, Colorado, Sewer  
34 Utility Enterprise for the period January 1, 2022 to December 31, 2022 are hereby amended by the  
35 following addition:

<u>FUND</u>	<u>EXPENDITURE</u>
Sewer Utility Enterprise	\$ 724,364

41 Section 2: The total budgeted expenditures for the City of Littleton, Colorado,  
42 Sewer Utility Enterprise for the period January 1, 2022 to December 31, 2022 shall be amended  
43 to \$25,699,571.

45 Section 3: Severability. If any part, section, subsection, sentence, clause or  
46 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the  
47 validity of the remaining sections of this ordinance. The City Council hereby declares that it would  
48 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase  
49 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or

50 phrases may be declared invalid.

52 **Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in conflict  
53 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer  
54 clauses of such ordinance nor revive any ordinance thereby.

59 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library,

60 the Municipal Courthouse and on the City of Littleton Website.
