8 AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF
9 LITTLETON, COLORADO, AS THE GOVERNING BODY OF THE
10 CITY OF LITTLETON STORMWATER AND FLOOD
11 MANAGEMENT UTILITY ENTERPRISE, AMENDING THE 2022
12 BUDGET

14 WHEREAS, the city council established the City of Littleton Stormwater and
15 Flood Management Utility Enterprise (the “Enterprise”) by Ordinance No. 33, Series of 2013; and

16
17 WHEREAS, the city council, as the governing board of the Enterprise, has the
18 authority under said ordinance to establish the budget for the Enterprise; and

19
20 WHEREAS, Ordinance No. 29, Series of 2021 established the budgeted
21 expenditures for the City of Littleton Stormwater and Flood Management Utility Enterprise; and

22
23 WHEREAS, the necessity of receiving and expending additional monies from the
24 Enterprise could not have been reasonably anticipated during the time of adoption of this budget
25 and appropriation of funds in accordance therewith.

27 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
28 THE CITY OF LITTLETON, COLORADO, THAT:

30 Section 1: The budgeted expenditures for the City of Littleton, Colorado,
31 Stormwater and Flood Management Utility Enterprise for the period January 1, 2022 to December
32 31, 2022 are hereby amended by the following addition:

38 Section 2: The total budgeted expenditures for the City of Littleton, Colorado, of
39 Littleton Stormwater and Flood Management Utility Enterprise for the period January 1, 2022 to
40 December 31, 2022 shall be amended to \$2,528,505.

42 Section 3: Severability. If any part, section, subsection, sentence, clause or
43 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
44 validity of the remaining sections of this ordinance. The City Council hereby declares that it would
45 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase
46 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or
47 phrases may be declared invalid.

49 Section 4: Repealer. All ordinances or resolutions, or parts thereof, in conflict

50 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer
51 clauses of such ordinance nor revive any ordinance thereby.
