AN ORDINANCE OF THE CITY OF LITTLETON, COLORADO, AMENDING ORDINANCE 27, SERIES 2021 KNOWN AS THE “ANNUAL APPROPRIATION BILL” ADOPTING THE BUDGET FOR ALL MUNICIPAL PURPOSES OF THE CITY OF LITTLETON, COUNTIES OF ARAPAHOE, DOUGLAS, AND JEFFERSON, STATE OF COLORADO, FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2022 AND ENDING DECEMBER 31, 2022

WHEREAS, Ordinance No. 27, Series of 2021 established the annual appropriation for municipal purposes for the City of Littleton, Colorado; and

WHEREAS, Ordinance No. 31, Series of 2021 amended the annual appropriation for municipal purposes for the City of Littleton, Colorado; and

WHEREAS, Ordinance No. 02, Series of 2022 amended the annual appropriation for municipal purposes for the City of Littleton, Colorado; and

WHEREAS, appropriations have theretofore been made for the expenditures of monies pursuant to said budget; and

WHEREAS, the council approves and supports the scope and deliverables of the public opinion polling and education; and

WHEREAS, it was noted with the development of the 2022 budget that should the economy prove to be more favorable than anticipated, staff would bring forward supplemental appropriations to address service levels and program needs; and

WHEREAS, the City consents to the release of the held 2022 budget proviso for public polling and community engagement in addition to the expenditure and appropriation of additional funds as set forth below.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:

Section 1: The budget of the City of Littleton for the fiscal year beginning January 1, 2022, and ending December 31, 2022, is hereby amended by the following additions:

48 **Section 2:** The provisions of the annual appropriations Ordinance No. 27,
49 Series of 2021, are hereby amended with the total of all fund expenditures amended to
50 \$101,716,450.

52 **Section 3:** The city manager is authorized to proceed with the public polling
53 and education as budgeted for in the 2022 city budget.

55 **Section 4:** Severability. If any part, section, subsection, sentence, clause or
56 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
57 validity of the remaining sections of this ordinance. The City Council hereby declares that it would
58 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase
59 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or
60 phrases may be declared invalid.

62 **Section 5:** Repealer. All ordinances or resolutions, or parts thereof, in conflict
63 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer
64 clauses of such ordinance nor revive any ordinance thereby.

68 of the City of Littleton on the 5th day of April, 2022, passed on first reading by a vote of 7FOR
69 and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the
70 Municipal Courthouse and on the City of Littleton Website.

71 PUBLIC HEARING on the Ordinance to take place on the 19th day of April, 2022,
72 in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado, at the
73 hour of 6:30 p.m., or as soon thereafter as it may be heard.

74 PASSED on second and final reading, following public hearing, by a vote of 5 FOR
75 and 2 AGAINST on the 19th day of April, 2022 and ordered published by posting at Littleton
76 Center, Bemis Library, the Municipal Courthouse and on the City of Littleton Website.
