8 AN ORDINANCE OF THE CITY OF LITTLETON,
9 COLORADO, REPEALING CHAPTER 7, TITLE 2, OF THE
10 CITY CODE REGARDING THE ESTABLISHMENT OF
11 THE LIBRARY BOARD

13 WHEREAS, on December 8, 2020, City Council held a study session to discuss
14 consolidating some of the City's Boards and Commissions; and

15
16 WHEREAS, at the December 8, 2020 study session City Council discussed the
17 benefits of combining some of the functions of the Library Board and Museum Board with the
18 Littleton Arts and Culture Commission; and

19
20 WHEREAS, at the December 8, 2020 study session City Council provided
21 direction to staff to repeal the Library Board.

23 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
24 THE CITY OF LITTLETON, COLORADO, THAT:

26 Section 1: Littleton City Code Chapter 7, Title 2 of the City Code regarding
27 the establishment of the Library Board is hereby repealed in its entirety.

30 Section 2: Severability. If any part, section, subsection, sentence, clause or
31 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
32 validity of the remaining sections of this ordinance. The City Council hereby declares that it would
33 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase
34 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or
35 phrases may be declared invalid.

37 Section 3: Repealer. All ordinances or resolutions, or parts thereof, in conflict
38 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer
39 clauses of such ordinance nor revive any ordinance thereby.

42 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council
43 of the City of Littleton on the 15th day of December, 2020, passed on first reading by a vote of 7
44 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the
45 Municipal Courthouse and on the City of Littleton Website.

46 PUBLIC HEARING on the Ordinance to take place on the 5th day of January, 2021,
47 in the Council Chamber¹, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado, at the
48 hour of 6:30 p.m., or as soon thereafter as it may be heard.
