AN ORDINANCE OF THE CITY OF LITTLETON, COLORADO, REPEALING CHAPTER 8, TITLE 2, OF THE CITY CODE REGARDING THE ESTABLISHMENT OF THE MUSEUM BOARD

WHEREAS, on December 8, 2020, City Council held a study session to discuss consolidating some of the City’s Boards and Commissions; and

WHEREAS, at the December 8, 2020 study session City Council discussed the benefits of combining some of the functions of the Library Board and Museum Board with the Littleton Arts and Culture Commission; and

WHEREAS, at the December 8, 2020 study session City Council provided direction to staff to repeal the Museum Board.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:

Section 1: Littleton City Code Chapter 8, Title 2 of the City Code regarding the establishment of the Museum Board is hereby repealed in its entirety.

Section 2: Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or phrases may be declared invalid.

Section 3: Repealer. All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer clauses of such ordinance nor revive any ordinance thereby.

INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council of the City of Littleton on the 15th day of December, 2020, passed on first reading by a vote of 7 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the Municipal Courthouse and on the City of Littleton Website.
